TERMS AND CONDITIONS

"Estrella Mágica" of the Asociación de Campings de Sant Pere Pescador

The Asociación de Campings de Sant Pere Pescador, with registered business address in Camí de Sant Martí d'Empúries, 5, Sant Pere Pescador, Girona, has organised a promotional competition via a specific internet website (http://campingspp.imaginartejuegos.com). The game is directed at people over 18 years of age and is governed by the following rules.

RUI FS:

- 1. DURATION: From the 15th of MAY, 2013 until the 15th of JUNE, 2013.
- 2. TERRITORIAL LIMITATIONS: There are no territorial limitations for participants on the competition.
- 3. PERSONAL LIMITATIONS: The competition is open to **anyone over 18 years of age** who has correctly completed the entry form, which can be accessed via the competition website.

Only one entry per email address is permitted.

No entries will be permitted from employees of companies who are part of the Asociación de Campings de Sant Pere Pescador or their families, or employees of any company involved in the development of the GAME.

Non-compliance with any of the rules established in this document will be considered grounds for disqualification of the user from the GAME.

4. COMMUNICATION OF RESULTS:

The competition results will be published via the GAME website (http://campingspp.imaginartejuegos.com), in the website of the Association (http://www.campinginsantperepescador.com), and in the websites of each of the camping parks belonging to the Asociación de Campings de Sant Pere Pescador.

5. PARTICIPATION:

Participants who register correctly between the 15th of May and the 15th of June, 2013, and who comply with all the rules established in this document will be eligible for the prizes detailed in section 8.

6. GAME DURATION AND CLASSIFICATION

Participants must submit their solution to the game between the 15th of May, 2013 and the 15th of June, 2013.

The prizes will be awarded to:

- A. The first 5 classified participants, which will be those who have submitted the first five correct solutions.
- B. Four further prizes will be drawn among participants who have submitted correct solutions and who are not included in the first 5 prize winners.
- C. One consolation prize will be drawn from among all the participants, whether or not they have submitted the correct solution.

No participant may be eligible for more than one prize.

Solutions will be submitted via the final form in the GAME website.

In the event that one of the 10 prize winners chooses not to claim their prize, the prize will be deemed void.

7. PRIZES

No participant may claim more than one prize.

It is established that:
